GUIDELINES ON THE RANKING AND RATING OF OP DELIVERY UNITS

FOR PURPOSES OF THE 2016 PERFORMANCE BASED BONUS (PBB)

1. The following guidelines are hereby issued by the OP Performance Management Group (OP-PMG) pursuant to Section 6.2i of Memorandum Circular (MC) No. 2016-1¹ issued by the AO 25² Inter-Agency Task Force (IATF), which requires agencies to post and disseminate a System of Ranking of Delivery Units (DUs).

GUIDELINES

2. Grouping of DUs.

All DUs have been grouped consistent with Section 8.2 of MC No. 2016-1, which provides that agencies should consider similarities of functions and responsibilities and with MC 2016-2, which provides guidelines on the identification and determination of DUs.³

3. Rating and Ranking of DUs.

Each DU shall be required to submit its Form A-1 to the OP-PMG Technical Working Committee (TWC) for review and assessment. DU accomplishments and targets will be compared. For DUs with targets that are fully met or exceeded by their accomplishments, the unit will be assessed as "Pass". Conversely, for DUs with accomplishments that fall short of their targets, the unit will be assessed as "Fail".

3.1. For DUs that Pass:

- (a) Each DU shall likewise be required to submit its Office Performance Commitment and Review (OPCR) Form and Form A-1 to the TWC for review and evaluation. The numerical office rating will be considered by the PMG to determine the DU's rating.
- (b) Using these ratings, the PMG shall "force-rank" each DU alongside the other DUs within their group, and determine which units are:

Top 10% of units
Next 25% of units
Remaining 65% of units

The distribution of which is as provided by Section 9 of MC No. 2016-1.

3.2. For DUs that Fail:

DUs that fail will be disqualified from the 2016 PBB. However, they may appeal in writing to the TWC, which in turn will make a recommendation on the appeal for the consideration of the OP-PMG.
