# One (1) Lot Procurement and Delivery of Spares for the Corrective Maintenance of B-412 Aircraft #1898, #1998, and #2000 with Purchase Request Number 21-10-1282 dated 07 October 2021

- 1. The Office of the President, through the General Appropriations Act (GAA) FY 2022 intends to apply the sum of ₱ 15,064,990.00 being the ABC to payments under the contract for Procurement of One (1) Lot Procurement and Delivery of Spares for the Corrective Maintenance of B-412 Aircraft #1898, #1998, and #2000 with Purchase Request Number 21-10-1282 dated 07 October 2021. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Office of the President now invites bids for the above Procurement Project. Delivery of the Goods is required by Ninety (90) Calendar Days. Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders) of the Bidding Documents.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 Revised IRR of RA No. 9184.
- 4. Interested bidders may obtain further information from **Office of the President** and inspect the Bidding Documents at the address given below from **8:00 AM TO 5:00 PM**.
- 5. A complete set of Bidding Documents may be acquired by interested bidders from January 4, 2022 to January 26, 2022 from 8:00 AM to 12:00 NN and from 1:00 PM to 5:00 PM, Monday to Friday, and up to 9:00 AM of January 27, 2022 at the given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (25,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person at the address given below.
- 6. The Office of the President will hold a Pre-Bid Conference on January 13, 2022, Thursday at 2:00 PM at the address given below and/or through video conferencing/webcasting via Zoom meeting, which shall be open to prospective bidders.

The BAC Meeting, including its Pre-bid Conference, will be conducted virtually (e.g. via Zoom) in accordance with the health protocols during COVID-19 pandemic. - Bids must be duly received by the BAC Secretariat through manual submission or in person at the address given below on or before January 27, 2022, Thursday at 10:00 AM. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **January 27**, **2022**, **Thursday at 10:05 AM** at the given address below and/or through videoconferencing/webcasting via **Zoom meeting**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The BAC Meeting, including its Opening of Bids, will be conducted virtually (e.g. via Zoom) in accordance with the health protocols during COVID-19 pandemic.
