## Description

One (1) Lot Procurement of CY 2022 Office of the President Fuel Requirements with Purchase Request Number 21-07-0001 (Negotiated Procurement – Two Failed Biddings)

The Office of the President, through the General Appropriations Act (GAA) FY 2022 intends to apply the sum of ₱ 53,534,600.00 being the ABC to payments under the contract for Procurement of CY 2022 Office of the President Fuel Requirements with Purchase Request Number 21-07-0001 (Negotiated Procurement Two Failed Biddings).
